#### 140/25 **RESOLVED**

#### Cr Robins / Cr Grattan

- 1. Note the significant decline in local enrolments at Kambora Public School, with numbers dropping from approximately 280 students in 2018 to just 41 in 2025.
- 2. Acknowledge the NSW Department of Education's consultation regarding the school's future, including the real risk of the school entering 'recess' from 2026.
- 3. Recognise that the Davidson area currently has an older demographic, which is expected to transition as properties change hands to younger families. This demographic shift is anticipated to increase demand for local primary school placements, potentially exceeding the capacity of neighbouring schools.
- 4. Recognise that the recent approvals of the Frenchs Forest Town Centre will, within a

decade, increase the demand on local primary schools as we actively attract young families to the area.

- 5. Write to the NSW Minister for Education, Shadow Minister for Education and the Member for Davidson and respectfully request that:
  - a. the NSW Department of Education (the Department) conduct transparent and genuine consultation with both the local community and Council before any final decision is made regarding the status of Kambora Public School.
  - b. the Department publicly release detailed enrolment data and projections for Kambora Public and neighbouring schools.
  - c. the Department provide a clear business case for any proposed changes, including analysis of the community impact of closure or 'recess', and options considered to boost enrolments.
  - d. the Department disclose the rationale for the lack of Department-led initiatives to attract students and support the school, despite ongoing concerns over declining numbers.
  - e. no irreversible action be taken regarding the future of Kambora Public School until:
    - i. the feasibility and community impact of all options are transparently reviewed and communicated
    - ii. local families, staff, and stakeholders have a real opportunity to have their voices heard
    - iii. the Department addresses the long-standing concerns about its support (or lack thereof) for Kambora.

  - b. Reduce the \$41,315 allocated to Australia Day events by \$21,315 and re-allocate

those funds to the community event grants and sponsorship program so that community, charitable and sporting organisations and local small businesses can apply for grant funding to conduct events on Australia Day and consequentially amend Council's respective policy to facilitate this.

- c. Delete Picnic in the Park proposed expenditure of \$46,064 and re-allocate those funds to the community event grants and sponsorship program so that community, charitable and sporting organisations and local small businesses can apply for grant funding to conduct events on Australia Day and consequentially amend Council's respective policy to facilitate this.
- d. Delete Place Event Open air cinema amounting to a cost saving of \$39,790.
- e. Delete International Women's Day proposed expenditure of \$9,600 and re-allocate those funds to the community event grants and sponsorship program so that community, charitable and sporting organisations and local small businesses can apply for grant funding to conduct events on Australia Day and consequentially amend Council's respective policy to facilitate this.
- f. Reduce the allocation of \$115,000 to arts and creativity grants to \$50,000, amounting to a \$65,000 saving.
- g. Reduce the allocation of \$132,443 to community library grants to \$50,000, amounting to a \$82,443 cost saving.
- h. Request the Chief Executive Officer (CEO) to furnish a report, at the earliest opportunity, to review any past, and introduce a new, sporting user levy to assist with maintenance costs and new sporting infrastructure.
- i. Request the CEO:
  - i. introduce an immediate freeze on the hiring of staff, particularly considering that the organisational structure must be resolved one year from the September election and is yet to be determined
  - ii. ensure a \$10 million reduction in the employment costs of management or by at least 30% in savings over the next 2 years
  - iii. explore a reduction of at least 20% to deliver \$20 million in savings over the next 2 years
  - iv. critically review Council's property portfolio and make recommendations to the July 2025 Council meeting to raise at least \$40 million over the next 2 years
  - v. explore and recommend any other internal cost saving measure as thought fit to mitigate a rate rise
  - vi. properly investigate the continual losses, noting since 2017 the over \$5.4 million loss on the Manly Art Gallery and Museum, the \$3.2 million loss on the Glen Street Theatre and the over \$107,000 loss on the Creative Art Spaces at Curl Curl, Mona Vale and Avalon, and ensure that such losses are reduced by 40% within the 2025/26 financial year.
- 4. Not pursue the direct employment of lifeguards from the former Pittwater LGA, which will cost approximately \$1.4 million and will add unnecessary salaries and oncosts to Council and ratepayers, as well as occasion unnecessary expenditure on required new infrastructure already provided by Australian Lifeguard Service.

In regard to the enforcement of road rules, community standards and safe behaviour practices the NSW Police play a critical role, however clearly the current regulatory scheme does not support that endeavour. With resources strained, in my view it is unacceptable to suggest or expect the Police Force to effectively respond to the issue currently, nor is it acceptable to ignore the problem.

Like any transport mode, there is a natural balance between freedom of movement and a blending of education and regulation to enable safe and acceptable behaviour for users and the wider community.'

- 2. Write to the Premier, Leader of the Opposition, Ministers and Shadow Ministers for Transport and Roads and all local State MPs calling for the introduction of stronger legislation on:
  - a. speeding of e-bikes on roads, and their presence on footpaths and shared paths
